ORDER

Government are pleased to appoint the following candidates advised by the Kerala Public Service Commission as District Educational Officers in the Education Department in the scale of pay of Rs 12250-19800 under Rule 9 (a) (i) of KS & SSR, as provided for in Rule 10 (b) of KS& SS Rules.

They are directed to report for training before the Director of Public Instruction, Thiruvananthapuram within 15 days from the date of receipt of this order failing which the appointment order will be cancelled and Kerala Public Service Commission will be addressed to cancel their advice without any further notice. They should bring their original documents to prove age, educational qualification and also medical certificates as prescribed in Rule 13 part I KSR (certificate signed by a Medical Officer not below the rank of a Civil Surgeon) and two passport size photographs. Candidates who are already employed should produce necessary relieving orders failing which, they will not be admitted to duty. Community certificate would also be produced for verification when they report for duty.

The Proforma appended to this orders should be filled up by the candidates themselves and the same should be produced duly signed when they report for duty. If the candidates fail to report with the above

documents within the allowed joining time, the appointment order shall stand cancelled.

The photograph and the signature of the candidate will be verified with that of the identity certificate and the fact will be recorded by the Director of Public Instruction on the identity certificate itself. If there is any discrepancy, the candidate should not be allowed to join duty and the fact should be reported to Government, forthwith. After the candidate is allowed to join duty, the identity certificate verified by the Director of Public Instruction and found acceptance may be kept pasted in the Service Book.

Immediately after joining duty the Director of Public Instruction will report the date of joining duty of the candidates to the Kerala Public Service Commission under intimation to Government.

The advice of the candidate is subject to Rule 3 (C) of the General Rules of the Kerala State & Subordinate Service Rules 1958. In the event of discharge from service for want of vacancies, the candidate may either re-register his / her name in the office of the Public Service Commission / District office of the Public Service Commission from where he/she was advised and get himself / herself re appointed on further advice by the Public Service Commission or he/she may wait for his/her turn for re-appointment to the post in the Department.

The Director of Public Instruction will take necessary measures to conduct the training for these officer in the SIEMAT, Thiruvananthapuram (State Institute of Educational Management and Training)The appointment to the post of the District Educational Officer would be subject to the result of WP(C) No.27381 of 2009 WP(C) No.27458 of 2009 and WP(C) No.27156 of 2009 pending before the Hon'ble High Court


