NOTIFICATION

Sub: Sanction of Financial Assistance for education to the children of Beedi/Lime Stone & Dolomite Mines/Cine workers for the year 2011-12

- 1. Labour welfare organisation, Government of India, Ministry of Labour & Employment is extending financial assistance for education to the children of Beedi/Lime Stone & Dolomite Mines/Cine workers who are studying in Government schools or Government Recognised Private Schools. The financial assistance ranges from Rs.250/- to Rs.8000/- depending upon classes, the student studying/Courses the student undergoing.
- 2. Eligibility criteria for grant of financial assistance are given in the Instructions Sheet enclosed to this letter.
- 3. Active contribution of the Head of Educational Institutions is requested to carry out this benevolent task. They are to send their proposals in the Prescribed Format (Revised). Guidelines are given in the Instructions Sheet enclosed to this letter for submitting their proposals.
- 4. Last date to receive the said proposals from the Head of Educational Institutions is 31st August 2011 Proposals not submitted in the Prescribed Format (Revised) or incomplete proposals or proposals received after the due date, i.e. 31st August 11 shall not be entertained under any circumstances.
- 5. Proposals shall be submitted by the Head of Educational Institutions only; and no application shall be entertained/ received directly from the student or any other Agency/Person.

6. Specimen Copy of the Prescribed Format (Revised) for 2011-12 can be obtained from this office in person, by post or through e.Mail.

INSTRUCTIONS

I ELIGIBILITY:

- 1. Either of the parent of the student should be a Beedi/LS&D Mine/Cine worker with minimum of 6 months continuous service.
- 2. Family income should not exceed Rs.10000/- in the case of Beedi worker and Rs. 8,000/- per month in the case of Cine worker or an amount not exceeding Rs.1 lakh where it is paid by way of lump sum or instalments. There is no income ceiling limit for mine workers.
- 3. Sons/daughters of contractors or supervisory staff are not eligible. (In case of mine workers those supervisory staff who are drawing less than Rs.10000/are eligible)
- 4. The applicant must have passed the last qualifying examination.
- 5. Student who receives scholarship from any other source during 2011-12 will NOT be eligible for grant of financial assistance for education.

II GUIDELINES FOR HEAD OF THE INSTITUTIONS:

- 1. The Head of the Institution should obtain duly filled in application in the prescribed pro-forma which is enclosed, from each student only once at their entry level. In other words, they should obtain applications along with attested copies of Identity Cards from each student in duplicate and forward a copy of the same, only in the case of "students admitted afresh"; and not for old/regular students.
- 2. After obtaining of applications the details in the prescribed statement duly filed in all respects should be submitted along with the renewal cases.
- 3. All the private schools are required to enclose a Xerox copy of recognition/ affiliation issued by the Competent Authority.
- 4. The statement should be prepared class wise in ascending order (viz.I,II,III etc)
- 5. The statement should be prepared separately Fund-wise ie Beedi/ Mine/Cine workers.
- 6. The consolidated statements should reach this office on or before 31st August 2011.
- 7. School/College code allotted by Labour welfare organisation should be invariably mentioned.
- 8. The Head of the institution should ensure the genuiness of the entitlement by verifying the records.

- 8. It is to be ensured that before submission of statement the previous years' acquitances for disbursement of financial assistance is sent to this office.
- 9. The financial assistance will be stopped in case any educational institution furnish wrong information and liable for de-recognition by the Competent Authority.
- 10. The Head of Institution concerned shall be personally responsible for the proper disbursement of the financial assistance.

III CANCELLATION/WITHDRAWAL OF FINANCIAL ASSISTANCE:

- 1. The Heads of the Institution are requested to cancel the financial assistance under the following circumstances:
- a. If the financial assistance is obtained on the basis of false statement.
- b. If the student discontinues his/her studies.
- c. In case of unsatisfactory progress/irregular attendance/guilty of misconduct/failed students.
- d. The parent ceases to be the employee of the Beedi/Mine/Cine Establishment.
- e. Student who after passing one stage of Education/professional course is studying the same stage of education in different subject/professional courses.


