ORDER

As per the order read as second paper above, Government have revised the scales of pay of State Government employees with effect from 1.7.2009. Pursuant to that, monetary limits in Rule 90 A, 93 and 103 of Part I and Appendix VII of the Kerala Service Rules, are required to be revised. Accordingly, Government are pleased to order as follows:

- (i) In clause (a) of Rule 90 A, the limit of Rs. 12,930/-, Rs. 4,525/- and Rs. 3,020/- will be enhanced to Rs. 22,360/-, Rs. 7,826/- and Rs. 5,220/- respectively.
- (ii) In the Exception below Rule 93, the limit of Rs. 10,790/- will be enhanced to Rs. 18,740/-.

(iii) In clause (b) of Rule 103, the limit of Rs. 8,390/- will be enhanced to Rs. 14,620/-.

(iv) In clause (i) of Rule 1 under Section II of Appendix VII, the limit of Rs. 9,190/- will be enhanced to Rs. 16,180/-.

The above orders shall have retrospective effect from 1.7.2009. In respect of those who opted to remain in the pre-revised scale of pay beyond 1.7.2009, the monetary limit will be as existing prior to this enhancement.

Formal amendment to Kerala Service Rules will be issued separately.
