ORDER

In response to the letter read as Ist Paper, Government had issued clarification to the Director of Public Instruction. Thirtyananthapuram that if the HSSTs appointed from among HSAs have already been confirmed/are eligible for confirmation in the post of HSSTs then they cannot be relieved to take up employment as HM/AEO as per Rule 26 of Part L KS&SSRs vide Covernment letter read as 2nd paper. Aggrieved by this, the petitioners filed appeals before the Government alleging that the clarification issued by Government would adversely affect the promotional prosperity since they are selected as HSSTs from among HSAs by transfer. They have also requested Government to direct the Director of Public Instruction. Thiruvananthapuram to promote them to the cadre of HM/AEO with effect from the date of their immediate juniors got promotion to the post of HM/AEO. While departmental action is underway based on their representation, they approached the Hon'ble High Court of Kerala for the same purpose by WP(C) No.18416/10. As per the judgement read as 3rd paper the Hon'ble High Court has directed Government to consider the Ext.P2 -P9 appeal petitions filed by the petitioners before the Government expeditiously at any rate, within a period of 3 months from the date of receipt of a copy of the judgement.

(2) Government have examined the matter in detail and decided to continue the same method as adopted in previous years in the promotional

aspects of the HSSTs selected from among the HSAs by transfer till a final decision is taken on the proposal put in by the committee headed by Sri.C.P.Nair before Government suggesting that the Secondary School Education should be made up to the Higher Secondary Education level. Accordingly, as per letter read as 4th paper, the Director of Public Instruction has been instructed that the method adopted in the previous years in the promotional matters of HSSTs as HM/AEO may be continued and further orders.

(3) In the above circumstances, in compliance of the judgement of the Hon'ble High Court of Kerala read as 3rd paper. Government are pleased to direct the Director of Public Instruction. Thiruvananthapuram to consider the promotion of the petitioners and other similarity situated persons as HM/AEO in the light of the clarification issued by Government vide letter read as 4th paper.

(4) The order of the Hon'ble High Court in the WP(C) No.18416/10 is thus

complied with.
