Vide proceedings read above, Education Department has issued guidelines with respect to the minimum specification, maximum price and service conditions for the procurement of computers and hardware for schools using various schemes including Local Area Development funds of MLAs & MPs, Plan funds of Local Self Government institutions etc. This was endorsed through Govt Orders 2nd and 3rd read above, making applicable the same to the respective departments. In the Union Budget 2012, Govt of India has enhanced the excise duty from 10.30% to 12.36% inclusive of CESS and the revised excise duty is effective from 17.03.2012. On the basis of this, the service Provider, KELTRON has informed the Project that the price of ICT equipments would change as per the enhanced excise duty. In the case of the billing against the orders after 31st March 2012, the applicable VAT will stand enhanced from 4.04% to 5%. Hence the rates of items as listed in the Proceedings 1st read are revised as follows;

The above rate obtained is through bulk procurement process and the delivery of the equipments except for 3 KVA UPS would be through a centralized mechanism. In case of remote locations, the distribution of equipments would be undertaken at one or two centralised locations in the district, from where the individual schools need to collect their equipments except in the case of 3 KVA UPS.

Proceedings read above stands modified to this extent. All other terms and conditions including service conditions remain the same.
