## ORDER No.H2/35920/11/DPI Dated 19-11-2011

Government as per order read as 1<sup>st</sup> paper above have approved a comprehensive package in principle for introducing a scientific method for appointment and deployment of teachers in aided schools. Accordingly the list of teachers who were not getting salary for various reasons have been collected from the Deputy Directors of Education and the same has been published as Appendix1 of the Government Order read as 2<sup>nd</sup> paper above with direction to approve their appointments without waiting for appellate orders, after ensuring that they are appointed against regular vacancies and qualified to hold the posts. In the meantime certain complaints have been noticed that some deserving cases have not been included in the list and some ineligible teachers are included by mistake. On consultation with the DDEdns/DEO's/AEO's, such cases are reexamined and the lists submitted by the Deputy Directors of Education of Kasaragod (31 teachers) have been verified in detail. They certified that there is no inclusion or exclusion error in the lists submitted by them.

In the above circumstances, the appointment in respect of the following teachers are accepted for approval with effect from 01-06-2011 in terms of Govt. Orders read as 1<sup>st</sup> and 2nd paper above

The appointments of substitutes appointed in the place of claimants as per Rule 43 of Chapter XIV A KER or seniors and whose names are included in the list shall be approved and paid salary after approving the appointment of 43 claimants and senior hands. The District Educational Officers/Assistant Educational Officers will ensure that there is sanctioned post to accommodate the teacher and issue formal approval of appointment orders in each individual cases within 7days from the date of receipt of this order and report to the undersigned by return.

The teachers will be paid pay and allowances from 01/06/2011 onwards. The approval given by the Educational officers will be subjected to further scrutiny by officers authorized by the Director of Public Instruction. The Educational Officers shall be held responsible for any discrepancies detected later and the loss sustained to Government shall be got realized from them.

Protected teachers now deployed in Government schools will continue as such for the time being and they will join in the Teachers Bank for training as and when PSC hands join duty in their place. The Deputy Directors of Education will report such vacancies to the Public Service Commission for advice of candidates immediately.

The Deputy Directors of Education will submit the list of retrenched teachers to the undersigned on or before 30-11-2011 and they will be deployed for training subsequently. Staff fixation orders of 2010-11 will hold during 2011-12 and teachers who are receiving salary as per Staff fixation 2010-11 will continue to be paid till the fixation on the basis of UID is completed.
