Sub: IEDSS 2013-14 - Provision of Therapeutic services (Physio/Speech Therapy) in general

ORDER No. IED/ 41451/13/DPI Dated 04/ 06/ 2013

Under the scheme IEDSS, there is a provision for therapeutic services under student-oriented component for the year 2013-14. This service will be provided to CWSN studying in general schools. Different types of therapies like physiotherapy, speech therapy etc. can be provided in general schools on a need-based manner. Support can be made at cluster level and needs of children with disabilities in a cluster of schools, can be addressed.

From 2009-10 to 2012-13, 26 speech therapy units and 57 physio therapy units have been started and equipments have been provided in general schools where Resource Centre/rooms have sanctioned and Resource Teacher is posted. The list of schools is given as under:

Fund has been sanctioned for the procurement of equipments for these therapy centres and all centres are functioning smoothly. Children with special needs (CWSN) are availing these services at free of cost from these therapy units.

Timings of therapeutic service will be one hour each in the morning and evening before and after the class hours on working days **only**, without suffering the class hours. *The unit should not function after 5 P.M.* If the unit functions after 5 PM, prior sanction from the Head Master should be taken by writing and then therapy can be provided in the presence of the parent of the child **only**. Minimum 3 hours of therapy service should be given to each student every week. On Saturdays, the unit will function from 10 AM to 4 PM except Second Saturday. **Therapy centre should not function on sundays and public holidays**. **The therapeutic services to CWSN** is provided **at free of cost** and **no fee should be collected from the students/parents by any means**. Resource Teacher of the school should maintain the attendance register of the students in the therapeutic unit, which is to be monitored by the Head Master concerned.

The services in the therapeutic unit will be extended not only for the students of the concerned school but also for the students of the surrounding schools or the area. Therapists are to be appointed through an interview conducted by an interview board consisting of DEO concerned, Head Master, PTA President, DIET Principal or DIET Faculty in charge of IED as his nominee, Ward councillor/Member and Experts in the area of Physio Therapy/Speech Therapy as the case may be. Wide publicity in the area should be given in print/visual media regarding the interview. The service of experts can be availed from Physio Therapists/Speech Therapists in Government Hospitals or from approved institutions. Presence of an expert in the respective therapy must be ensured in the interview board. Sitting fee and T.A. to the experts in the Interview Board is to be provided by school PTA. Remuneration of the therapists has been fixed @ Rs.150/- per hour limited to a maximum of 50 hours per month. Minimum qualification for the therapist appointed should have Degree in the respective area of Therapy along with 2-year experience. In the absence of degree holders in the area of therapy, diploma holders with 2-year experience can be considered. Appointee should not have any claim to the post he is appointed and the appointment will not come under the purview of KER/KSR. A bond in Stamp paper for Rs.100/- with photo fixed on it should be executed by the appointee with the Head Master concerned which is to be kept in the school itself for record purpose.

Hence permission is hereby granted to the Head Masters to appoint therapists in above schools through interview for the year 2013-14. If the parents & School authorities are satisfied with the service of the existing therapist, he/she can be re-appointed without interview, if he/she is interested. Otherwise, fresh interview should be conducted, with wide publicity, as mentioned above.

After appointing Speech Therapist/Physio Therapist by conducting interview or after re-appointment, Head Master concerned should forward the joining report of the therapist and the attested copy of his bio-data and qualification certificates countersigned by DEO concerned to the IED cell of DPI within 5 days of his/her joining duty. Head Master should maintain a register for attendance and number of hours of therapy for disbursing remuneration to him on time. A register for remarks from parents on the therapy service(s) is also to be maintained by the Head Master concerned. The Head Master and PTA should strictly monitor the services provided and report to DDE/DEO concerned if any difficulty is faced in the implementation.
