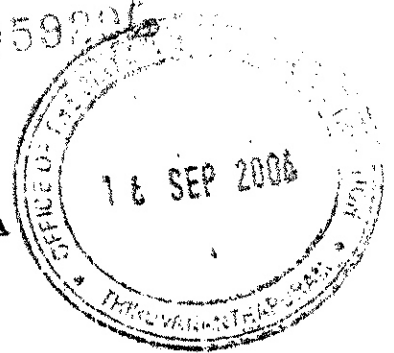

ORDER

In the Government Order read above the rate of scholarship to Muslim/Nadar Girl Students in Upper Primary and High School Classes was enhanced to Rs. 75/- and Rs. 100/- respectively per annum and the parental income for enjoying the benefit of scholarship was also enhanced to Rs. 18,000/- per annum from the academic year 1995-96. The Director of Public Instruction in his letter read as 2nd paper above has requested Government to enhance the rate of scholarship from Rs. 75/- to Rs. 125/- per annum in upper primary classes and from Rs. 100/- to Rs. 150/- in High School Classes.

Government have examined the matter in detail and are pleased to enhance the rate of scholarship to Muslim and Nadar girl students in Upper Primary and High School classes from Rs. 75/- and Rs. 100/- to Rs. 125/- (Rs. One Hundred and Twenty Five Only) and Rs. 150/- (Rs. One Hundred and Fifty Only) respectively per annum and the parental income for enjoying the benefit of scholarship in Upper Primary and High School Classes from Rs. 18,000/- (Rs. Eighteen Thousand Only) per annum to Rs. 25,000/- (Rs. Twenty Five Thousand Only) per annum from the academic year 2006-07.

All other Girl Students belonging to all backward classes and all Girls Students of other communities who are below the poverty line is also eligible to this scholarship.


