The Heads of Institutions concerned will relieve the persons under order of promotion immediately on receipt of this order with instruction to report for duty at their new stations forthwith under intimation to this office. Those who wish to relinquish the right for promotion should submit written relinquishment in the form appended to this order through their Institutions within 7 days. The Heads of Institutions concerned will counter-sign the said statement of relinquishment and forward the same to this Office immediately.

The Heads of Institutions will ensure that the promotees possess B.Ed. or B.T. Degree and test qualifications (Account Test Lower and KER) or are eligible for temporary exemption from acquiring departmental test qualification on completion of 50 years of age. The Heads of Institutions will also ensure that the HSAs language should have completed 12 years of Graduate Service as on the date of this Order. Government Vide Letter No.12970/C2/2010/G.Edn dated.07-04-2010,clarified that as per rule 26 Part I KS&SSRs HSST are not eligible for promotion to the cadre of HM/AEO.Hence the Heads of Institutions need not relieve the HSSTs if any included in this order. If there is any doubt the promoters need not be relieved and fact should be reported to this office immediately for further instructions.

If anybody after getting their names included in the Seniority List published as per this office Proceedings No. SY.1/16868 /2006 / DPI. dated. 22.09.2006 and SY1/40558/07/DPI dt.15.09.07 and subsequent revision of seniority have obtained inter-district transfer by loosing seniority such promotees need not be relieved and the fact should be reported immediately. The Controlling Officers should verify the Service Book of the promotees to the effect before relieving them to take up the new appointments. The promotions if found necessary will be reviewed subject to the final decision in the WP(C)No.16577/10,17511/10,19647/10,18146/10 and W P (C) 30246/10.

If any of the promotees left the service or are on leave etc. by this time, the fact will be reported to this office at once. Similarly, if any of the promotees has since been transferred form the school mentioned in the column No.4 the Heads of Institutions will


forward the orders to the Heads of the Institutions where he / she is working at present under intimation to this office.
